The American Revolution

There will be two lectures a week and a section meeting on most weeks of the term. All readings are on reserve in the Library; those marked with an * are also available in the bookstore. Two short papers, an hour test, and the final exam are required. The topic of the research paper must be worked out in consultation with Prof. Wood or a teaching assistant. The research paper will be due on April 28 at the History Department, 142 Angell St., by 4:00 p.m.

Attendance at the section meetings is required, and section participation will be graded. Only one unexcused absence from the section meetings will be allowed.
